Tax-favored Charitable Gifts

To make a charitable gift in 2024 for Federal Income Tax purposes, you must make your gift **on or before December 31, 2024**. There are many ways to make a charitable gift to a qualified organization, such as the Archdiocese of Omaha, please find a summary of tax advantaged options and how to make a gift to the Archdiocese of Omaha below.

Make a Qualified Charitable Distribution (QCD) of Individual Retirement Account (IRA) assets

If you are 70½ or older, a QCD charitable distribution is a way you can support the work of the Church.

- *Benefits of a QCD charitable distribution*
 - Avoid taxes on transfers of **any amount** up to \$100,000 from your IRA to the archdiocese, your parish or school
 - Make a gift that is not subject to the deduction limits on charitable gifts
 - Help further the work and mission of the Church
- *How a QCD charitable distribution gift works*
 - Contact your IRA plan administrator to make a gift from your IRA to the Church
 - Your IRA funds will be directly transferred to the Church to help continue our important work; they must be directly transferred from your IRA to the charitable organization to count as a Qualified Charitable Distribution
 - Please note that IRA charitable rollover gifts do not qualify for a charitable deduction, but they can count as all or part of your required minimum distribution

Gift of Stock

A gift of long-term appreciated publicly traded stock may entitle the donor to an income tax charitable deduction for the fair market value of the stock on the effective date of the gift and also avoid capital gains tax. In many cases it is more advantageous for a donor to donate the securities to a qualified organization than to sell the securities and donate the cash proceeds. If you have stocks that have lost value, but you still wish to use them to make a donation, they should be sold first and then the proceeds donated. However, we recommend that you consult your tax advisor for additional information.

2. Contact Doug Foley, Data Support Office, at 402.558.3100, or the Stewardship & Development Office at 402.557.5650 to ensure the archdiocese is aware of your pending stock transfer.

Upon receipt of the transfer, we will issue a stock transfer receipt to you. The gift is valued as the average of the high and low market price of the stock on the day of the transfer. Please note that the entire transfer process can take several business days.

NEW! To donate cryptocurrency

Donating long-term appreciated cryptocurrency to the Archdiocese of Omaha allows donors to avoid paying capital gains tax and be able to claim the tax deduction for the fair market value of the cryptocurrency if they itemize. To mail a gift via USPS

Ensure the gift is postmarked by December 31, 2024
